







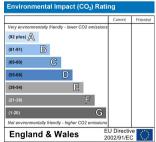
Floor Plans Location Map
